▶ The consignor is informed that the racing pigeons are transported in a suitable ventilated vehicle by an agent trained and authorised for the Transport of Live Animals (TAV) categories of small mammalian/birds. The vehicle shall not transport any species other than racing pigeons.

▶ The sender is informed that the driver who collects the animal packages from the sender may have reservations about the transport of the animals (unsuitable boxes, pigeons that are ill or in poor condition, absence of the required administrative formalities).

▶ The consignor shall use packaging methods that ensure that transport is carried out in the best possible conditions for the racing pigeons. The packaging must allow the racing pigeons to be watered and fed (see FCF for technical recommendations on packaging). The packaging must protect the animals it contains from all sources of external injury or suffering, must allow the animals to breathe without constraint or effort, must be sufficiently resistant to crushing, must be single-use, and must allow control of the moisture induced by the pigeons' droppings. The bottom of the packaging must be equipped with an excrement absorption system (litter). The dimensions of the packaging must be

appropriate to the pigeons and quantities transported, and must allow each of the birds enclosed to stand, turn around and lie down without constraint.

Packages shall be accepted only on condition that they have been designed and prepared in such a way that the animals contained therein do not require any care or direct handling for twice the total expected duration of the transport.

The package shall be accompanied by a transport voucher (which shall be equivalent to a contract) with the sender (identity, contact details), the place, date and time of departure, the receiver (identity, contact details), the place, date and time of arrival, the number of pigeons transported in the package, any document justifying the legal origin of the animal (intra-Community certificates, TRACES declarations), possibly the title deed and pedigree to be handed over to the sender. The transport voucher is issued by the FCF after collection of the information and payment of the race.

The pigeons must be provided with water from 12 hours of travel (and feed from 24 hours of travel) - Feeding from the outside of the package.
